- The criteria for **Climara, Estalis, Estracomb, Estraderm, Estrogel, Oesclim** and **Vivelle** have been revised as follows:
 - For patients:
 - (a) who are smokers (current);
 - (b) with increased triglycerides;
 - (c) with a history of cholelithiasis; or
 - (d) who cannot tolerate oral estrogens due to intolerable side effects (eg. GI upset, irregular bleeding, etc) or who cannot take any medications by mouth. Patients should have tried at least two different oral estrogen products (eg. Premarin, Estrace, Ogen).
- The criteria for **Duragesic** has been revised as follows:
 - For treatment of pain in patients unable to tolerate oral analgesics or when there is failure to adequately control pain with oral analgesics or in patients in whom oral analgesics are deemed inappropriate.

 - (a) For the secondary prevention of vascular ischemic events ie. myocardial infarction, or stroke

- (i) who are known to be or become intolerant to ASA, or
- (ii) who continue to have TIA or stroke symptoms or myocardial infarction while being treated with ASA or clopidogrel.

NOTE: ASA should be first line for the secondary prevention of vascular ischemic events such as myocardial infarction or stroke. Before abandoning ASA, efforts should be made to improve tolerability of ASA by reducing the dose, taking it with food and using enteric coated ASA.

(b) Post coronary stent implantation x 28 days in combination with ASA.

- Where at least two other non-steroid anti-inflammatory drugs (NSAIDs) have been tried and failed or were not tolerated.

- For transplant patients who are experiencing:

- (a) Ongoing rejection despite maximally tolerated therapy with other agents (ex. CsA, MMF, tacrolimus). Rapamune would be added to existing therapy.
- (b) Acute or chronic calcineurin inhibitor related side effects (nephrotoxicity, neurotoxicity, etc). Rapamune would be added to existing therapy in an attempt to decrease doses of calcineurin inhibitors.

NOTE: Rapamune should not be used for monotherapy or first line therapy.

Upon the prescription of a nephrologist within the Provincial Dialysis Program, for control of hyperphosphatemia (> 1.8 mmol / L) where increased calcium carbonate is not warranted due to :

- A. Hypercalcemia, with ionized calcium >1.35 mmol/L or total calcium >2.65 mmol / L despite reduction in calcium carbonate dose and change of calcium in dialysis bath to 1.2 mmol / L ; OR, inability to utilize or increase calcium carbonate in the dialysis bath due to unacceptable hypercalcemia.
OR
- B. Clinically relevant soft tissue calcification based upon nephrologist's evaluation. Incidental calcification noted on x-ray is NOT an indication.
OR
- C. Calcium carbonate intolerance defined as unequivocal inability to utilize or increase calcium carbonate in order to maintain serum phosphate levels < 1.8 mmol/L.
OR
- D. Excessive calcium carbonate intake, defined as patient required to take in excess of 18 calcium carbonate 250 mg tablets per day.
