2023/24	Major	A patient received an unintended medication resulting in a serious outcome requiring emergent intervention and an unplanned admission to hospital.
2023/24	Major	A patient experienced an acute change in their medical condition. The opportunity for earlier recognition and intervention was not realized.
2023/24	Major	A client ingested a substance that was not secured and experienced a change in their medical condition that required transfer to a higher level of care.
2023/24	Major	A patient experienced a delay in diagnosis of a serious medical condition.
2023/24	Major	Client developed a skin wound that resulted in amputation.
2023/24	Major	A patient required a second surgical procedure due to the use of the incorrect medical device.
2023/24	Death	A patient experienced delays in recognition and treatment for an acute medical condition.
2023/24	Death	Gaps in monitoring led to delayed recognition and response to a clinical deterioration.
2023/24	Major	There were delays in recognition and response to a significant change in a patient's condition.
2023/24	Major	A patient had a fall with serious injury.
2023/24	Major	An opportunity for earlier diagnosis and intervention was not recognized. The patient required readmission to hospital.
2023/24	Death	A patient experienced an acute change in their condition. While immediate interventions were provided, the opportunity for earlier consultation to additional resources was not realized.
2023/24	Major	A resident experienced skin tissue breakdown requiring increased care and intervention. Early opportunities to provide intervention were not consistently realized.
2023/24	Major	A patient experienced a fall resulting in an unwanted outcome.
2023/24	Death	Gaps in monitoring led to an unwanted outcome.
2023/24	Major	A patient experienced delays in recognition and treatment for an acute medical condition requiring a transfer to a higher level of care.
2023/24	Death	A patient experienced an acute change in their medical condition as a result of a medical device failure.
2023/24	Death	A patient presented with an acute medical condition. While immediate interventions and consultations were provided, there was a delay in transfer to a higher level of care.

2023/24	Major	A delay in a patient's diagnostic testing contributed to a delay in diagnosis and treatment.
2023/24	Major	A patient required emergency surgery due to a delay in diagnosis and treatment.
2023/24	Death	A resident experienced a change in their medical condition. The opportunity for earlier recognition and intervention was not realized.
2023/24	Major	A patient experienced a change in their medical condition that was recognized by care providers, however the opportunity for earlier consultation and treatment was not realized.
2023/24	Death	There was a delay in response to a deteriorating patient. Opportunities for earlier assessment and intervention were not realized.
