Claims Submission Procedure – Advanced Glucose Monitors (AGM)

Effective March 14, 2023 Updated August 27, 2024

Please include this Procedure in your Drug Programs Information Network (DPIN) Manual under Section 4: Claims Submission.

- Effective **March 14, 2023**, coverage for Advanced Glucose Monitors (AGM), which includes Continuous Glucose Monitors (CGM) and Flash Glucose Monitors (FGM), is expanded to all eligible Manitobans with type 1 or type 2 diabetes who meet eligibility criteria.
- The new Part 2 eligibility criteria for AGM is as follows (and can be found in <u>Bulletin</u> <u>125</u>):

For patients with type 1 or type 2 diabetes currently on both basal <u>and</u> bolus insulin or using an insulin pump.

Note: According to Diabetes Canada's Types of Insulin Table:

- Intermediate-acting and long-acting insulins are considered basal insulins.
- Rapid-acting and short-acting insulins are considered bolus insulins.
- Premixed regular insulin-NPH and premixed insulin analogues are considered to contain both a basal and bolus insulin.
- The pharmacist must verify against the DPIN history that the client meets the above eligibility criteria before submitting a claim to DPIN with an EP exception code.
- Where a prescription for AGM indicates the client "Meets EDS" the pharmacist should submit the claim to DPIN with an ED exception code.
- Clients with an existing Exception Drug Status (EDS) approval for AGM supplies who meet the new Part 2 eligibility criteria will no longer require EDS renewal.
