RESOLVED that a sum not exceeding Three Billion, Four Hundred Seventy Million, Fifty Thousand Dollars (\$3,470,050,000.00), being Forty-Nine Percent (49%) of the total amount to be voted as set forth in Part A (Operating Expenditure) of the Estimates, be granted to Her Majesty for the Fiscal Year ending the 31st day of March, 2004.

Wednesday, September 17, 2003

RESOLVED that a sum not exceeding Twenty-Six Million, Nine Hundred Forty Thousand Dollars (\$26,940,000.00), being Forty-Six Percent (46%) of the total amount to be voted as set out in Part B (Capital Investment) of the Estimates, be granted to Her Majesty for the Fiscal Year ending the 31st day of March, 2004.

Resolutions were reported and the Report was received.

Hon. Mr. SELINGER moved:

THAT there be granted to Her Majesty on account of Certain Expenditures of the Public Service for the Fiscal Year ending March 31, 2004 out of the Consolidated Fund, the sums of Three Billion, Four Hundred Seventy Million, Fifty Thousand Dollars (\$3,470,050,000.00), being Forty-Nine Percent (49%) of the total amount to be voted as set out in Part A (Operating Expenditure) and Twenty-Six Million, Nine Hundred Forty Thousand Dollars (\$26,940,000.00), being Forty-Six Percent (46%) of the total amount to be voted as set out in Part B (Capital Investment) of the estimates, laid before the House at the present Session of the Legislature.

And the Question being put. It was agreed to.
