The following petitions were presented and read:

Mrs. TAILLIEU – Legislative Assembly of Manitoba to urge the Premier to consider reversing his decision to increase Pharmacare deductibles by 5 percent in Budget 2008 and to consider reducing health care bureaucracy, as previously promised, and to consider directing those savings into sustaining Pharmacare and improving patient care. (E. Huzarewich, E. Palson, B. Rosentreter and others)

Mr. DYCK – Legislative Assembly of Manitoba to request the Minister of Health to strongly consider giving priority for funding to develop and staff a new 100 bed long-term-care facility so that clients are not exposed to unsafe conditions and so that Boundary Trails Health Centre beds remain available for acute care patients instead of waiting placement clients. (R. Griffin, A. Martens, I. Ching and others)

Mr. MAGUIRE – Legislative Assembly of Manitoba to request the Minister of Health to consider creating a health care environment in which doctors want to work and build their careers in Manitoba and to consider making it a priority to recruit doctors to southwestern Manitoba so emergency rooms do not have to be closed when they are needed most. (L. Pearn, R. Kellsey, G. Morris and others)

Mr. LAMOUREUX – Legislative Assembly of Manitoba to urge the Provincial Government to consider establishing a 90 day guarantee for processing an application for a minimum of 80% of applicants that have family living in Manitoba and to consider removing the use of the restrictive job list when dealing with the family sponsor stream. (J. Aquino, M. Santiago, M. Gonzales and others)

Mr. EICHLER – Legislative Assembly of Manitoba to urge the Provincial Government to consider developing a comprehensive recovery strategy aimed at addressing both the immediate and the long-term effects of this year's excess moisture conditions and flooding; and to consider examining all types of programming to help producers recover from this disaster, including emergency, one-time programs, as well as improvements to the crop insurance program to address its shortfalls; and to consider addressing shortcomings with drainage and the processing of drainage permits. (O. Olson, L. Henry, R. Forsyth and others)

Mr. BRIESE – Legislative Assembly of Manitoba to urge the Provincial Government to consider developing a comprehensive recovery strategy aimed at addressing both the immediate and the long-term effects of this year's excess moisture conditions and flooding; and to consider examining all types of programming to help producers recover from this disaster, including emergency, one-time programs, as well as improvements to the crop insurance program to address its shortfalls; and to consider addressing shortcomings with drainage and the processing of drainage permits. THAT Bill 17 be amended in Clause 2 by striking out "the Schedule" and substituting "the regulations" in the proposed subsection 40.1(1).

And the Question being put. It was negatived, on division.

Mr. EICHLER then moved:

THAT Bill 17 be amended in Clause 2 by striking out "or" at the end of subclause (i) of the proposed clause 40.1(2)(a), adding "or" at the end of subclause (ii) and adding the following after subclause (ii):

(iii) an environmentally sound treatment that results in

(A) no phosphorus being applied to the land, or

(B) phosphorus being applied to the land at a rate that does not exceed the amount of phosphorus to be removed by the intended crops over a five-year crop rotation cycle;
