Mr. GOERTZEN moved an amendment as follows:

THAT the motion be amended by deleting all the words after the word "THAT" and substituting the following:

Bill (No. 33) – The Municipal Modernization Act (Municipal Amalgamations)/Loi sur la modernisation des municipalités (fusions), be not now read a second time but that it be read a second time this day six months hence.

WHEREUPON Mr. Speaker ruled the amendment in order.

And the debate continuing on the amendment,

And Mr. MAGUIRE speaking at 5:00 p.m. The debate was allowed to remain in his name.

Mr. Speaker advised the House that notice had been received from the Leader of the Official Opposition that he had designated his unlimited speaking time for Second Reading of Bill Bill (No. 33) – The Municipal Modernization Act (Municipal Amalgamations)/Loi sur la modernisation des municipalités (fusions) and all amendments arising from Second Reading to the Honourable Member for Arthur-Virden.

During the debate, Mr. Deputy Speaker interjected and requested that the words "lies of the Premier" spoken by the Honourable Member for Arthur-Virden be withdrawn.

WHEREUPON Mr. MAGUIRE withdrew his remarks.

The House then adjourned at 5:00 p.m. until 10:00 a.m. Tuesday, May 28, 2013.
