In accordance with Rule 33(8), the Opposition House Leader announced that the previously debated Provincial Government's Plan to Shutter Three Winnipeg Emergency Rooms will Undermine Patient Care and Hurt Families and Seniors Resolution will be considered on the next Thursday of Private Members' Business.

The House resumed the Interrupted Debate on the Proposed Resolution of Mr. KINEW:

Resolution No. 9: Keeping Post-Secondary Education Affordable for Students and Families

WHEREAS the Provincial Government has lifted the cap on post-secondary tuition hikes which limited tuition increases to the rate of inflation, allowing tuition to be raised by five percent plus inflation and deregulated course fees; and

WHEREAS universities in Winnipeg and Brandon are preparing to raise tuition at the maximum rate, meaning thousands more dollars in tuition and course fees for students over a four year degree; and

WHEREAS university tuition must be affordable and accessible to all students and parents; and

WHEREAS a tuition hike will hit low-income students and families the hardest, and some students in Manitoba are already using extra supports like food banks to afford their education; and

WHEREAS tuition is the number one barrier to post-secondary education and Manitoba should continue to have the third lowest tuition fees in Canada; and

WHEREAS maintaining the cap on tuition fees will ensure that Manitoba universities can continue to attract students from all socio-economic backgrounds and allow everyone in the province to access education; and

WHEREAS the Premier has frozen wages for public sector workers at the same time he opened the door to tuition hikes, making it harder for students to access post-secondary education and find good paying jobs thereafter; and

WHEREAS the Premier introduced legislation to lift the tuition cap without consulting with students or their families, despite meeting with student leadership several times.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to withdraw Bill 31 and maintain the cap on tuition fees so they rise by only the level of inflation and education remains affordable for every student and family in Manitoba.

Hon. Mr. CULLEN presented:

Reply to Written Questions (Nos. 1 to 5), asked by Hon. Mr. FLETCHER, on October 5, 2017:

- 1. During the last four years of the previous Provincial Government, the provincial deficit totaled \$2.18 billion. Could the Minister of Finance advise why the most recent four year budget projection calls for a 26% increase totaling \$2.95 billion, given that the current Provincial Government campaigned on reducing the deficit and introducing a balanced budget?
- 2. Will the Premier confirm his long held commitment to balanced budget legislation, recently affirmed in the 2016 provincial election campaign, by not introducing any new taxes, premiums or levies such as either a carbon tax or health care tax in the form of a premium without first receiving approval from the people of Manitoba in the form of a referendum?
- 3. Why did the Provincial Government create a new Crown Corporation to deal with such matters as drinkable water and transportation, and support the \$30 billion construction of three new hydroelectric power dams, Bipole III and a new transmission line in the United States, when many alternatives are available to meet the needs of Manitobans without incurring huge debts, increasing the size of government, and which would avoid massive rate hikes?
- 4. Given the current and potential negative implications of Manitoba Hydro expansion and the debt and utility rate hikes involved, will the Provincial Government call a public inquiry to provide a full public understanding of the plans pursued and actions taken by Hydro, as supported by the former Provincial NDP Government?
- 5. Will the Provincial Government allow the following Private Member's Bills:
 - (No. 212) The Conflict of Interest Act
 - (No. 213) The Gift of Life Act (Human Tissue Gift Act Amended)
 - (No. 202) The Insurance Amendment Act
 - (No. 203) The Electoral Divisions Amendment Act
 - (No. 205) The Brookside Cemetery Recognition Act
 - (No. 206) The Legal Profession Amendment Act (Queen's Counsel Appointments)
 - (No. 225) The Manitoba Public Insurance Corporation Amendment Act
