for the operation of two space heating used oil burners located at 144 Provincial Truck Highway 12 North in the City of Steinbach, and in accordance with the Application filed under The Dangerous Goods Handling and Transportation Act on September 30, 2004 and the additional information dated July 6, 2006 and subject to the following specifications, limits, terms and conditions:

DEFINITIONS

In this Licence,

"Director" means an employee of the department who has been designated or appointed by the Minister;

"Facility" means all buildings, structures, process and pollution abatement equipment, storage facilities and land used by the Licencee for the purposes of burning used oil in a space heating used oil burner;

"Licencee" means Harvest Investments Ltd., its successors and assignees;

"Space heating used oil burner" means any device, implement, mechanism or appliance that meets the definition of "Oil Burning Equipment" as defined in CAN/CSA Standard B139 Installation Code for Oil Burning Equipment, as updated from time to time:

"Used oil" means oil that through use, storage, handling, defect, damage, expiry of shelf life or other similar circumstances can no longer be used for its original purpose.

GENERAL TERMS AND CONDITIONS

This Section of the Licence contains requirements intended to provide guidance to the Licencee in implementing practices to ensure that the environment is maintained in such a manner as to sustain a high quality of life, including social and economic development, recreation and leisure for present and future Manitobans.

- 1. The Licencee shall operate the facility is in accordance with the application dated September 30, 2004.
- 2. The Licencee shall burn only used oil as a fuel in the space heating used oil burners.
- 3. The Licencee shall store all used oil;
 - a) in accordance with Manitoba Regulation 188/2001, the Storage and Handling of Petroleum Products and Allied Products Regulation, as amended from time to time, where applicable;
 - b) in a manner to minimize any potential release or fire hazard; and
 - c) in tanks that have been constructed and tested in accordance with one of the following standards:
 - i) U.L.C. S601, latest edition; overhead horizontal tanks;
 - ii) U.L.C. S630, latest edition; vertical aboveground tanks;
 - iii) U.L.C. S643, latest edition; overhead horizontal utility tanks;
 - iv) API Standards 650, latest edition; vertical aboveground tanks;
 - v) ORD-C142.23, latest edition; aboveground waste oil tanks;
 - vi) ULC-S652, latest edition; tank assemblies for collection of used oil;
 - vii) U.L.C./ORD-C142.23, latest edition; waste oil tanks; or
 - viii) U.L.C./ORD-C142.3, latest edition; contained steel aboveground tanks.
- 4. The Licencee shall position the burner chimneys to prevent the intrusion of combustion fumes into any adjoining air intake, window or door.
- 5. The Licencee shall dispose of all ash that can be classified as a hazardous waste, produced by combustion in the space heating used oil burner, by a hazardous waste disposal company or in a manner approved by the Director.

- 6. The Licencee shall supply to the Director, no later than June 30, of each year, a written report summarizing the amount of used oil combusted in the space heating used oil burners for the previous July 1-June 30 heating season.
- 7. The Licencee shall perform, on a minimum monthly basis, the following maintenance operations where applicable:
 - a) the heat exchangers and flue piping for the space heating used oil burners are vacuum cleaned:
 - b) all sludge collected in the stainless steel hot filter element is removed; and
 - c) ash and other deposits are removed from the drip legs.
- 8. The Licencee shall clean the flue stacks annually, at minimum.
- 9. The Licencee shall retain records of the actions required in Clauses 7 and 8 of this Licence for five years and these records shall be made available to an Environment Officer upon request.
- 10. The Licencee shall install the space heating used oil burners in accordance with The Gas and Oil Burner Act Chapter G30 and accompanying regulation.
- 11. The Licensee shall not store more than 4500 litres of used oil at the facility at any given time.

REVIEW AND REVOCATION

- A. This Licence replaces Licence No. 199 HW which is hereby rescinded.
- B. If, in the opinion of the Director, the Licencee has exceeded or is exceeding or has or is failing to meet the specifications, limits, terms, or conditions set out in this Licence, or in the opinion of the Director a hazardous situation exists, the Director may, suspend, withdraw or cancel this Licence.
