### SPECIFICATIONS. LIMITS. TERMS AND CONDITIONS

- 1) The Licensee shall construct the Development in accordance with the alignment described in the Department of Highways *Proposed Location Plan No. 5875* filed as part of the Environment Act Proposal, dated June 15, 1992.
- 2) The Licencee shall not construct any works in the vicinity of the crossings of Willow Creek and its tributaries until after June 15th.
- 3) The Licencee shall apply the "Recommended Fish Protection Procedures for Stream Crossings in Manitoba" during the construction of works in the vicinity of the crossings of Willow Creek and its tributaries.

#### REVOCATION

If in the opinion of the Director, the Licensee has not complied or is not complying with the specifications, limits, terms and conditions setout herein, the Director may revoke, temporarily or permanently, this License.
