for the construction and maintenance of the Development being a water level control dam for minnow aquaculture at the outlet of Wentworth Lake in Section 28, Township 22, Range 16 EPM subject to the following specifications, limits, terms and conditions:

Specifications. Limits. Terms and Conditions

- 1) The Licencee shall construct the Development in accordance with methods outlined in the Environment Act Proposal dated January 31, 1992.
- 2) The Licencee shall obtain a work permit from Natural Resources, Eastern Regional Director, prior to commencement of construction activities.
- 3) The Licencee shall obtain the written approval of the Director, prior to beginning construction of the fish ladder, for the design of the fish ladder which will be incorporated into the dam.
- 4) The Licencee shall construct the dam so that a minimum crest length of 15 metres is maintained. The elevation of this crest shall not exceed the elevation of a permanent benchmark which will be established adjacent to the dam by the Department of Natural Resources prior to beginning construction of the Development.
- 5) The Licencee shall construct the Development with fill material obtained from the overburden piled adjacent to the site. The area of construction shall be restored to its original state.
- The Licencee shall use only existing access roads for the construction and maintenance of the Development. New roads shall not be constructed.
- 7) The Licencee shall ensure that all waste oil products generated by the machinery used in the construction and maintenance of the Development shall be collected and disposed of in accordance with applicable Manitoba Environment legislation requirements.
