In accordance with the Manitoba Environment Act (C.C.S.M. c. E125) this Licence is issued to:

The Turtle River Watershed Conservation District #2: "the Licencee"

for the construction and operation of the Development being a water development and control project in the Rural Municipality of Ste. Rose on Hansen Creek in Section 34-22-14W and Sections 3,9,10,16 and 17-23-14W subject to the following specifications, limits, terms and conditions:

Specifications, Limits, Terms and Conditions

- 1) The Licencee shall construct the Development in accordance with the Environment Act Proposal dated February 23, 1993 submitted by A. Ewashko Consulting on behalf of the Licencee.
- 2) The Licencee shall, prior to contracting or beginning construction activities, submit, for the approval of the Director, a plan showing present vegetative cover, the proposed extent of clearing of riparian vegetation and channel obstructions, and the proposed extent of channel trimming.
- 3) The Licencee shall reseed areas of disturbed ground resulting from mechanical clearing with a mixture of native or introduced grasses or legumes.
- 4) The Licencee shall limit bank clearing to a maximum width of 5 metres.
- 5) The Licencee shall ensure that bank clearing does not aggravate erosion into the stream. Banks cleared as part of this Development at any location where erosion is currently occurring shall be stabilized to prevent further erosion.
- 6) The Licencee shall remove only channel obstructions consisting of deadfall trees, dense bush growth and beaver dams. These obstructions shall be removed only if they significantly impede streamflow.
- 7) The Licencee shall not remove naturally occurring rises in the bottom of the channel and shall not channelize the stream in any location.
- 8) The Licencee may widen constricted areas of the stream channel to a width of 3 metres by trimming the cleared stream bank. The channel bottom shall not be affected by this activity.

- 9) The Licencee shall ensure that all waste oil products generated by the machinery used in the construction of the Development are collected and disposed of in accordance with applicable Manitoba Environment and legislation requirements.
- 10) The Licencee shall, during construction, ensure that fuel storage areas established for the construction of the Development shall comply with the requirements of Manitoba Regulation 97/88R respecting Storage and Handling of Gasoline and Associated Products.

Revocation

If, in the opinion of the Director, the Licencee has exceeded or is exceeding the limits, or has not complied or is not complying with the specifications, terms or conditions set out herein, the Director may revoke this Licence either temporarily or permanently.
