In accordance with the Manitoba Environment Act (C.C.S.M. c. E125)

THIS LICENCE IS ISSUED TO:

**THE LOCAL GOVERNMENT DISTRICT OF FISHER; the "Licencee"**

for the construction, maintenance and operation of the Development involving the construction of 650 meters of new road and crossing of the East Branch of the Fisher River on the Marble Ridge Road located north of Section 22-25-1W in the Local Government District of Fisher subject to the following specifications, terms and conditions:

**SPECIFICATIONS, LIMITS, TERMS AND CONDITIONS**

1. The Licencee shall construct the Development in accordance with the Environment Act Proposal filed on July 17, 1995.
2. The Licencee shall, prior to construction startup, instruct the project construction supervisor to arrange a pre-construction meeting with the Manitoba Department of Natural Resources Central Region Office in order to ensure compliance with the specifications, limits, terms and conditions of this Licence during the full term of construction of the Development.
3. The Licencee shall, prior to construction, consult and reach an agreement with the Manitoba Department of Natural Resources Wildlife Branch regarding habitat enhancement opportunities on undeveloped land within the Development.
4. The Licencee shall, prior to construction, locate borrow areas a minimum distance of 100 meters from any active stream channel.
5. The Licencee shall, from April 15 to June 30 of each year during construction, cease all construction activities that may impact upon the stream channel and banks of the East Branch of the Fisher River which may affect fish mobility and fish habitat.
6. The Licencee shall, during construction of the crossing of the East Branch of the Fisher River, adhere to the Manitoba Department of Natural Resources' guidelines titled *Recommended Fish Protection Procedures for Stream Crossings in Manitoba*.
7. The Licencee shall, during construction of the Development, use sediment control traps. The traps shall be cleaned of silt and debris following construction.

8. The Licencee shall, during construction of the Development, use erosion resistant material to construct the stream banks and streambed at the culvert crossing and the road surface of the overflow area. Following construction, side slopes shall be protected with rip-rap.
9. The Licencee shall, following the placement of riprap at the ends of the diversion channel, open the downstream end of the diversion before opening the upstream end.
10. The Licencee shall, during construction of the crossing, countersink the culverts to a minimum depth of 30 cm below the existing stream bed. Granular material and larger cobble/fieldstone shall be used to backfill inside the culverts to stream bed level.
11. The Licencee shall, as part of the Development, construct rock riffles at the downstream end of the crossing in accordance with specifications provided through consultation with the Manitoba Department of Natural Resources Fisheries Branch and Department of Fisheries and Oceans.
12. The Licencee shall, during construction, ensure that any fuel storage areas established for the construction of the Development and any heavy equipment repair and maintenance associated with the construction of the Development, are located a minimum distance of 100 meters away from waterbodies. The storage and equipment maintenance areas shall comply with the requirements of *Manitoba Regulation 97/88R - Storage and Handling of Gasoline and Associated Products Regulation*.
13. The Licencee shall, during and following completion of construction of the Development, collect and dispose of all waste petroleum products generated by the construction activities in accordance with all applicable regulatory requirements.
14. The Licencee shall, during the full term of the construction of the Development, cleanup and deposit all debris from the construction site at a Waste Disposal Ground operating under the authority of a permit issued pursuant to *Manitoba Regulation 150/91R - Waste Disposal Grounds Regulation*.
15. The Licencee shall, following construction, seed disturbed bank areas with natural grasses or herbs.

#### REVOCATION

If in the opinion of the Director, the Licencee has exceeded or is exceeding the limits, or has not or is not complying with the specifications, terms and conditions set out herein, the Director may revoke temporarily or permanently, this Licence.
