

AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION

UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION AND ANCAST INDUSTRIES LTD., Applicant,

WHEREAS pursuant to the provisions of The Clean Environment Act, Ancast Industries Ltd., filed an application with the Department of Mines, Resources and Environmental Management in connection with the operation of an existing iron foundry located on property as described in Appendix "A" attached to this Order, at or near 1350 Saskatchewan Avenue in the City of Winnipeg, Manitoba;

AND WHEREAS in the absence of limits being prescribed by a Regulation under the said Act, the said application was referred to The Clean Environment Commission for the prescribing of limits;

AND WHEREAS no representation was made by any person who is, or who is likely to be, affected by an Order of the said Commission prescribing limits in connection with the said application;

AND WHEREAS the said Commission considered the said application on the 27th day of October, 1975;

IT IS HEREBY ORDERED THAT

1. The Applicant shall ensure that, on and after the 1st day of November, 1977, subject to Clause 2, emissions arising from the said operation do not exceed the following limits:

- (a) solid particulate emission from any stack or vent of the said operation do not exceed 0.57 grams per standard cubic meter calculated at 20° Celsius and 760 millimeters of mercury (0.25 grains per standard cubic foot calculated at 68° Fahrenheit and 29.92 inches of mercury);

1. (b) visible smoke emissions from any part of the said operation do not exceed:


(i) 20% opacity (equivalent to No. 1 on the Ringelmann Smoke Chart*) for a period totalling more than four minutes in any one-half hour nor for more than eight continuous minutes at any time, and

(ii) 40% opacity (equivalent to No. 2 on the Ringelmann Smoke Chart*) at any time.

*"Ringelmann Smoke Chart" means the Ringelmann Smoke Chart published by the United States Bureau of Mines and used in accordance with the instructions published by the Bureau. Smoke density may also be measured by any other instrument which can be co-related with the standard Ringelmann Smoke Chart.
