**RE: R.M. OF TACHÉ – COMMUNITY OF LORETTE
WASTEWATER TREATMENT LAGOON EXPANSION -
NOTICE OF ALTERATION – FILE No: 4482.10**

On behalf of our client, we would like to apply for an alteration to the submitted Environment Act Proposal dated August, 2015 for the proposed lagoon expansion in Lorette.

We propose that a 300 mm diameter (HDPE) pipe segment complete with gate valves and cleanout be installed through the south dyke of the proposed secondary cell 3 (see attachment). The pipe would be capped off on the outside of the dyke and would not be used at this time.

As stated in previous correspondence, the R.M. of Taché is considering their options in potentially transferring liquid from the secondary cell of the Landmark wastewater treatment lagoon into the proposed secondary cell 3 of the Lorette lagoon in order to make use of the proposed phosphorus removal system.

If this option is ever pursued, a notice of alteration would be submitted to Manitoba Conservation and Water Stewardship (CWS) along with the details of the connection

that would be made. The submission would also include a lagoon capacity review. The intent is to install the pipe, valves and cleanout during the construction associated with the Lorette lagoon expansion, scheduled for 2016. Completing the installation at this time would allow the R.M. to complete a future connection between the lagoons without disturbing the dyke of secondary cell 3.

We understand that no fee is applicable for this minor alteration since the Environment Act Proposal is currently under review.

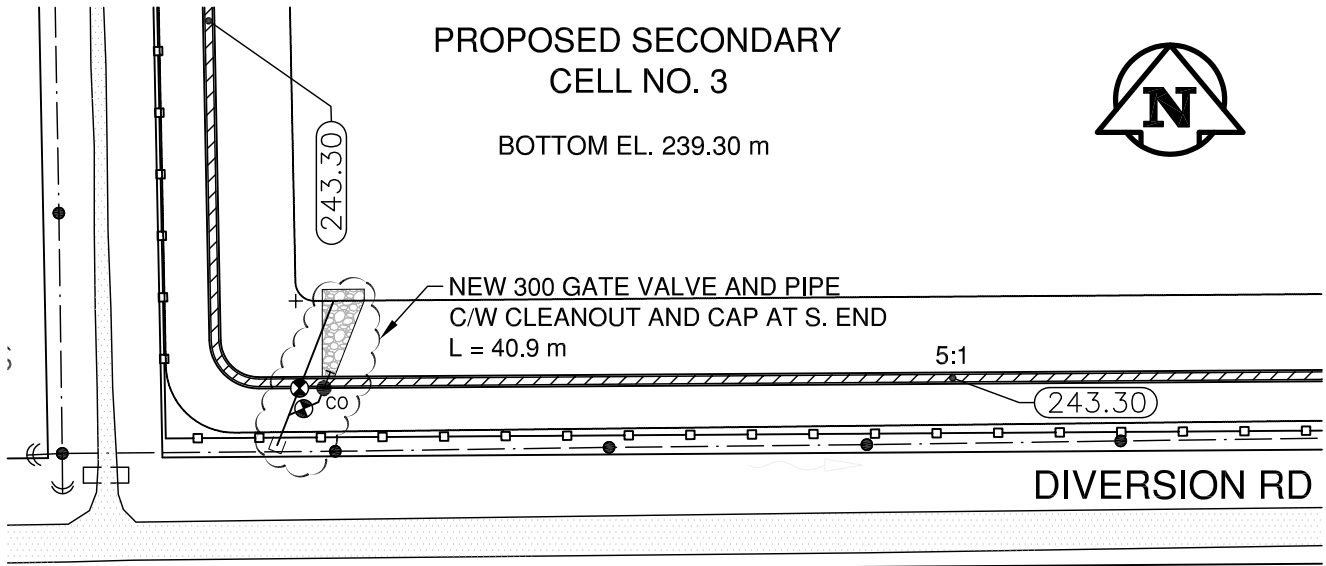

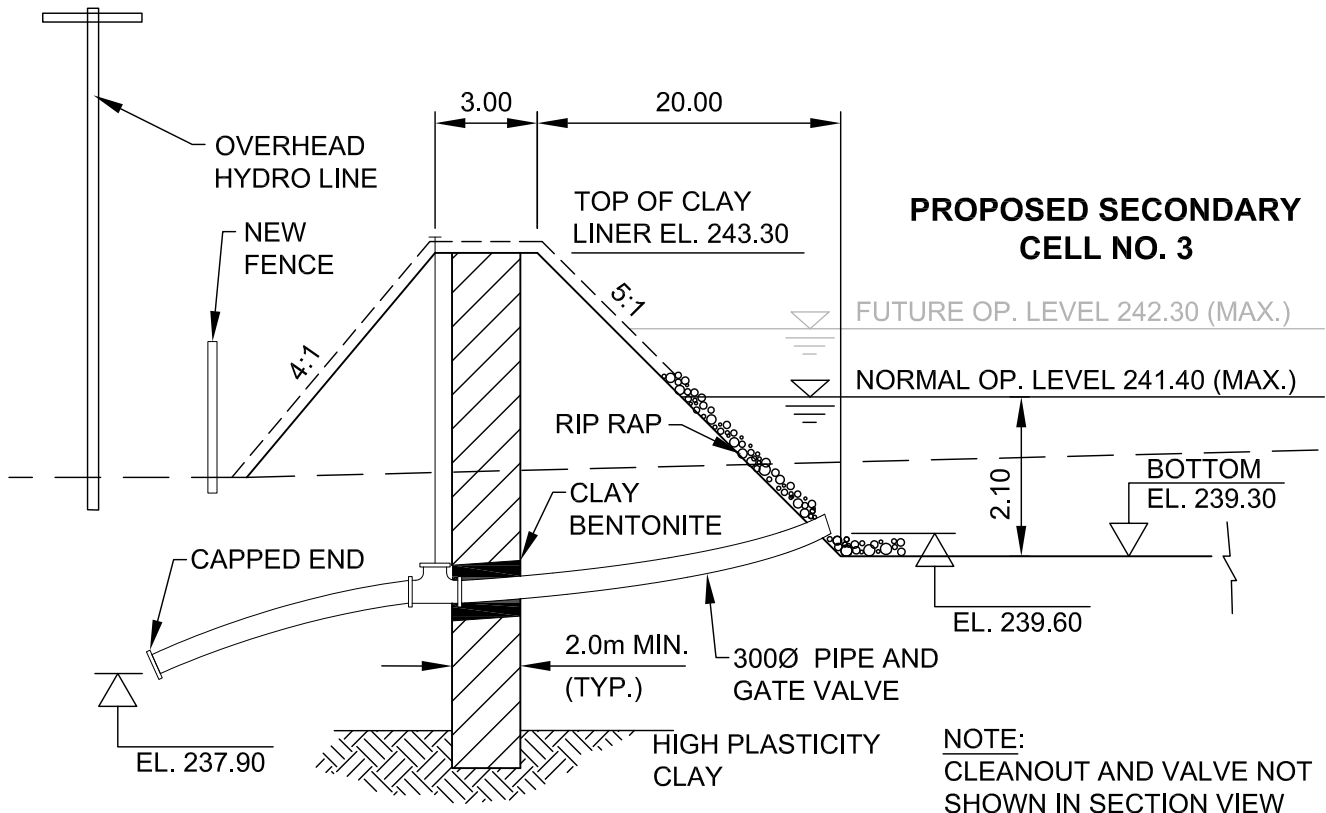
