APPENDIX 3A SUMMARY OF CONSULTATIONS

#### 3.0 PUBLIC CONSULTATION

The consultation program was established to provide stakeholders an opportunity to become informed about and engaged with the Project at the earliest possible stage to address or resolve issues and concerns through an open and collaborative process. Sections 3.1 through 3.4 of this EA summarize the principles and goals of the consultation program and key issues identified through the process.

#### 3.1 Public Consultation

Table 3.1 of this EA provides a list of provincial and federal government agencies that have been contacted to date. Contact with government agencies took the form of letters, email and telephone discussions. Project updates will be provided on a regular basis to interested agencies and subsequent meetings arranged as necessary.
