Sorry for the delay in responding. Fisheries Branch has reviewed this proposal to continue the operation of a waste lead acid battery transfer facility at 314 Dawson Road North in Winnipeg. The batteries are stored indoors in the non-ferrous warehouse which is fully covered by a metal roof and has a concrete floor throughout. The batteries are stored on pallets. The applicants are proposing to place plastic containment trays under the wooden pallets during storage. If this review is just for the temporary storage of batteries then given the information provided and the location of the facility it would appear that there are no fisheries concerns. Are the other components such as the drain tower and fluid extraction system already licenced?
