RE: City of Thompson – City of Thompson Wastewater Treatment Plant – Minor Notice of Alteration Approval – Environment Act Licence No. 3118 R

I am responding to the Notice of Alteration request dated December 23, 2019 and additional information submitted on January 7, 2020 and January 15, 2020, relative to a request for alteration to Clauses 13(b) and 13(g) of Environment Act Licence No. 3118 R (Licence), originally issued for the construction and operation of the Development being a wastewater collection system and a wastewater treatment plant located on Lot C, Plan 4657 in Township 78 and Range 3 WPM in the City of Thompson. The submission is considered a Notice of Alteration (NoA) pursuant to Section 14 of The Environment Act.

The intent of the NoA is to extend the completion of the construction and commissioning of the new wastewater treatment plant from August 30, 2019 to July 31, 2020 (i.e., alteration to Clause 13(b)), and to extend the due date to submit the report on total phosphorus discharge from the existing wastewater treatment facilities from September 30, 2019 to January 31, 2020 (i.e., alteration to Clause 13(g)).

Receipt of the total phosphorus report submitted on January 31, 2020 is hereby acknowledged. Upon review of the NoA and pursuant to Section 14(2) of the Environment Act, I hereby amend and replace Clause 13 of the Licence as follows:

13. The Licencee shall:

- a) submit progress reports every month from the date of this approval until final commissioning summarizing the design, construction and commissioning of the wastewater treatment plant; and
- b) complete the construction and commissioning of the wastewater treatment plant on or before August 30, 2020.

All other clauses of Environment Act Licence No. 3118 R remain in effect.
