There are many issues that have to be addressed to ensure that the water quality of Sandy Lake does not deteriorate further and having a means to maintain water levels is a very important one.

I am writing to make sure you are aware that this is an important issue that has to go forward.

I also feel that a notice in a weekly paper that many people who have an interest in the water levels will not see in the winter months may not the best way to get feedback from cottage owners. Most of these people are at the lake in the summer months and they may not have an opportunity to give their feedback as they may not see your notice.

Hi Bruce my name is Tom Sherb and I own a cottage at Serenuk Dr. We have owned it for 40 years or more.

Before the high water levels starting in 2009/10 we had large area on the lake side of the cottage ,about 50 ft. from the water and all in mowable grass.

When the water receded all there is now is sand. When the lake was at it's highest it was 10 to 15 ft. under the cottage ,making it unusable for 4 years .

The only reason the cottage was saved from major damage is because the lake side is on cement pads and metal posts due to the slope of the land .

In 2015 the water had receded about 30 ft. This let us use the cottage but we have spent about 8,000 dollars to date in repairs.

The news that the water level is to be controlled is of great relief for the future. We are in full agreement of the proposal.

In the past 7 years our beach has been flooded, the algae blooms have increased from the phosphates running into the water and the trees that have fallen in and died due to the flooding. The impact of the flooding on the ecology of the area has been significant. If the lake water level is not controlled the impact on the local economy will also be significant.

As a cottage owner our taxes are higher than the taxes in town. We get no services in our area. This includes no garbage , water or sewer.

The temporary structure that has been used for the past two years is just a band aid solution and this issue needs to be resolved as soon as possible.
